1	Whether KREDL can share the data for GO's already recommended to committee which is pending for processing.	In the GO under process, KREDL will only recommends to SLAC for approval. However, disclosing of information before the approval will be examined.		
2	Online GO application and approval process with a provision for uploading all the required documents in a portal in line with the Industries Department.	Online application system will be evaluated		
3	NA conversion process for renewable project should be in line with other states and town planning dept. is taking 10% of land. WIPPA has also said, they have listed the challenges related to land with legal counsel of IPPs and they wish to make a detailed presentation (to be made by legal firm of IPP) to govt.	To address this issue, KREDL will follow up with the Energy Dept, to have a joint meeting with ACS, Energy Dept and Town Planning Dept. to solve the matter.

9	GO Validity extension fee waiver for at least 1 year	GO extension fee is made for the purpose of bringing seriousness among developers to complete the project on time, in which other states are also collecting in different form. If any developer doesn't get the project commissioned within the period including extension, the GO will be automatically cancelled.
10	Connectivity/Synchronization approval with the existing Karnataka RE Policy 2022-27 referred only to CTU Connected/STU Connected/CTU Connected through STU - No representation is available for the Captive consumer with a dedicated transmission line.	There were similar case in the past from JSW and it was cleared in the State Level Allotment Committee. Even without mentioning the same in the policy, the cases are not being denied from project development.
11	Name Change fee needs to be waived off for shifting the name between two different SPVs under the same parent company. At present if the CIN number is different between two SPVs even if it comes under the same Parent company (Rs 1.5 Lakhs/MW as Name transfer fee has to be paid).	It will be examined.
12	The areas which are falling near the airport/Defence zones need to be marked in the master database and earmarking of boundaries needs to be done [Especially in Bidar and Challakere regions].	State have made detailed assessment on this, and have submitted a request to MNRE to address the issue at interministerial level of GOI.
